Cost Assessment and Program Evaluation (CAPE)

The Office of Cost Assessment and Program Evaluation was established in 1961. The

office is located within the Office of the Secretary of Defense and reports directly to the Secretary. The staff includes a



combination of civilian government employees and military officers and is augmented by contractor support. CAPE's civilian staff is drawn from a variety of academic disciplines, including, but not exclusively, physics, economics, and engineering. The CAPE staff is recognized as among the most capable in the Pentagon.

The Office provides independent analytic advice to the Secretary of Defense on all aspects of the Defense program, including alternative weapon systems and force structures, the development and evaluation of defense program alternatives, and the costeffectiveness of defense systems. The office also conducts analyses and offers advice in a number of related areas, such as military medical care, school systems for military dependents, information technology, and defense economics. Consistent with its ad-



visory role, the office has no decision authority or line responsibility and has no vested interest in any sector of the defense budget. CAPE has always been a reflect-

ion of the particular Secretary of Defense for whom it is working, and its actions have been tailored to his objectives, including the often unpopular but necessary task of fitting the Defense program to the budgetary limits set for the Department by the President.

- Cost-effectiveness of defense systems and programs
- Intelligence, surveillance, and reconnaissance systems
- Simulation of warfare and transportation systems

- Theater and mobility assessments
- Cost analyses for weapon systems
- Economic and manpower analyses
- Procurement planning
- Military medical care
- Information technology
- Defense economics

- Review, analyze, and evaluate programs, including classified programs, for executing approved strategies and policies.
- Provide leadership in developing and promoting improved analytical skills and competencies, tools, data, and methods for analyzing national security planning and the allocation of resources.
- Ensure that the costs, effectiveness, and capabilities of DoD programs, including classified programs, are presented accurately and completely.
- Assess effects of DoD spending on the U.S. economy and evaluate alternative policies to ensure that DoD programs can be implemented.

Is CAPE Right For You?

CAPE is seeking highly talented professionals with graduate education in quantitative fields, as well as demonstrated analytical ability. Since the issues CAPE works with tend to be broad, it is necessary to have a desire and ability to see the big picture and to rapidly acquire knowledge beyond a particular field of expertise. An excellent ability to communicate, both orally and in writing, is essential.

At least twenty-four semester hours of quantitative courses, three semester hours of which must be calculus, are required to qualify for an Operations Research Analyst position. A security clearance is also required to work in the organization.
